AFGHANISTAN

On August 13, 2021, the Taliban completed their sweep of Afghanistan as they took the capital city of Kabul just weeks before the US and coalition forces were set to officially end their two-decades-long war. The deteriorating humanitarian crisis in Afghanistan is exacerbating preexisting challenges, including poverty, hunger, and escalating violence in the country. In recent weeks, reports of war crimes, including summary executions, public beatings, and flogging of women, sexual



violence, and forced marriage, have surfaced in the areas captured by the Taliban.

Endangered Scholars Worldwide is gravely concerned about the well-being of students, scholars, and human rights activists in Afghanistan. While we call for the Taliban to restrain from violence and repression, we believe that the international community must prioritize helping the people of Afghanistan under the Taliban's reign. During the regime's brutal previous rule, schools were closed, girls were forbidden from classrooms and could only leave their homes with a male patron—girls as young as nine were forced into marriages.

Afghan students and scholars, who have already lived their entire lives through conflict and war, have a right to live free from violence, go to school, and engage in scholarly work safe from harm.

ESW urges the global community to make all efforts to respect obligations under international human rights and international humanitarian law, which includes ensuring free and unhindered humanitarian access to people in need of assistance and protection and open borders for the safe movement of people.

Continuing cases: On March 16, 2021, gunmen ambushed a bus transporting university students, staff, and professors in Baghlan province, killing the driver and a student. Six university lecturers were also injured. The attack took place during the morning rush hour on the outskirts of the provincial capital city of Pul-e-Khumri while the bus was traveling toward Baghlan university.

In recent years, students, professors, and academics have been increasingly targeted in violent attacks—an unacceptable trend that damages the future of society at large. Endangered Scholars Worldwide condemns these heinous crimes in the strongest possible terms and stands in solidarity with the victims' families.

Continuing cases: Though Bahrain released 1,486 prisoners on March 17, 2020, in response to the COVID-19 pandemic, imprisoned scholars and students were excluded from the decrees, including ABDULJALIL AL-SINGACE, 57, former head of the Department of Engineering at the University of Bahrain. Students JAWAD AL-MAHARY, SHAWQI RADHI, JASSIM AL-HULAINI, JASSIM AL-MUKHODHER, YOUSIF AHMED and AHMED AUON also remain in prison for their involvement in prodemocracy demonstrations. ESW calls on the US Department of States, the UN High Commissioner for Human rights, and the European Parliament to continue to press the Bahrain authorities to release all prisoners of conscience, especially those who pose no threat to the public, as COVID-19 spreads rapidly in Bahraini prisons.

Continuing cases: The whereabouts of renowned Uyghur poet and professor of Xinjiang Normal University, ABDULQADIR JALALIDIN, detained more than three years ago, and of TASHPOLAT TIYIP, 63, renowned scholar of geography, and former president of Xinjiang University (XJU), remain unknown, and the risk of execution cannot be ruled out. Other detained or disappeared academics include RAHILE DAWUT, a leading expert on Uyghur folklore and traditions at Xinjiang University who was disappeared by the Chinese government in 2017 and has not been

seen since; Kashgar University's president, ERKIN OMER; its vice president, an Uyghur Afghan National, MUHTER ABDUGHOPUR; Professor QURBAN OSMAN; Professor HALMURAT GHOPUR, president of the Xinjiang Food and Drug Administration's Department of Inspection and Supervision and former president of the Xinjiang Medical University Hospital; and ILHAM TOHTI, recipient in absentia of the 2019 Sakharov Prize for Freedom of Thought.

Students who remain in prison on charges of "separatism" and their connection to Ilham Tohti are PERHAT HALMURAT, SHOHRET NIJAT, LUO YUWEI, MUTELLIP IMIN, ABDUQEYUM ABLIMIT, ATIKEN ROZI, and AKBAR IMIN.

Continuing case: Like all dictatorships, China regards freedom of thought and political openness as dangerous. As China exerts increasingly tighter control over Hong Kong, its universities, long beacons of academic freedom, are under threat and risk losing their autonomy and internationally respected status. ESW believes that universities and academics around the world must take a firm stand when academic freedom is threatened abroad because, ultimately, the global challenge of defending our rights requires collective and institutionalized action. We call on the Chinese government to uphold the legally binding Joint Declaration in which Beijing solemnly vows that freedom "of speech, of

the press, of assembly, of association, of travel, of movement, of correspondence, of strike, of choice of occupation, of academic research, and of religious belief" would "remain unchanged for 50 years."

Continuing cases: AHMED SAMER, 29, an Egyptian anthropology student at the Central European University in Vienna who was arbitrarily detained in Egypt in early February 2021, remains in custody. As of this report, Samer has had no access to lawyers or to his family. University of Bologna student PATRICK GEORGE ZAKI, who was granted Italian citizenship on April 14, 2021, has been in custody since February 7, 2020, and has been allegedly tortured and mistreated by Egyptian authorities.

Endangered Scholars Worldwide also remains deeply concerned about the arbitrary arrest and sentencing of five Cairo University academics in the aftermath of the September 2019 protests against the Egyptian government. IRAN

Iranian authorities curtail the rights of freedom of expression, association, and assembly by arresting and imprisoning, on vague charges, professors, students, human rights defenders, and others who voice dissent. Torture and other mistreatments of detainees remain common and have been committed with impunity; prison conditions are harsh. Unfair trials continue, resulting in some cases with death sentences. Dual citizens and members of ethnic and religious minorities face discrimination both in law and in practice. Endangered Scholars Worldwide deplores and condemns the ongoing detention, persecution, conviction, and mistreatment of dual nationals in response to their exercise of the rights to academic freedom, free expression, and free association

New information: On August 5, 2021, Endangered Scholars Worldwide learned that NILOUFAR BAYANI, 34, a researcher, conservationist, and scholar who has been imprisoned in Tehran since February 2018 and has been serving a 10-year prison sentence since February 2020 on charges of espionage, was transferred to the Evin Prison quarantine ward after testing positive for COVID-19. Reports indicate that Iranian authorities do not provide proper medical care to detainees in the quarantine ward. Bayani, the program manager for the Persian Wildlife Heritage Foundation, previously worked as a project consultant for UN Environment and as a research assistant at McGill University. She was convicted on November 23, 2019, and sentenced to ten years in prison on charges of "contacts with the US enemy state" and "gaining illegitimate income." The ongoing outbreak of COVID-19 in Iran's prisons has accentuated the urgent need to release political prisoners. We urge the officials of the Iranian government to release all prisoners of conscience, especially those who pose no threat to the public, as COVID-19 spreads rapidly in Iranian prisons.

On May 11, 2021, ESW learned that AHMADREZA DJALALI, an Iranian-Swedish specialist in emergency medicine facing execution in Iran for espionage, has been moved out of solitary confinement in Iran, according to his family and his lawyer. Djalali, 49, a professor, physician, and researcher affiliated with the Karolinska Institute near Stockholm, who focused on crisis management, was arrested in April 2016 on charges of "collaboration with a hostile government" while visiting his family in Tehran. He was later accused of providing information to Israel to aid in the assassination of several senior nuclear scientists and, following a closed trial, was sentenced to death on October 20, 2017. In a joint statement issued on July 21, 2021, 14 international academic and human rights groups called on the US and European governments to secure Djalali's release.

Continuing cases: Academic freedom has long been under threat in Pakistan. Endangered Scholars Worldwide is deeply alarmed by the recurring wave of vicious campaigns against academics in Pakistan, particularly the blasphemy-related violence against lecturers, professors, researchers, and students, which is fostered in part by government persecution and discriminatory laws. It is increasingly common that vigilantes take blasphemy law into their own hands before the courts get involved, and authorities have failed to establish adequate protection for universities. Since 1990, at least 77 people have been murdered by angry mobs or assassinated on allegations of insulting Islam, including ten academics.

Continuing Cases: Scholars and researchers who remain in prison include ABDUL KAREEM YOUSEF AL-KHODER, a professor of comparative jurisprudence at Qassim University who was convicted on multiple charges, including insulting the judiciary, describing the regime as a police state, and participating in unauthorized associations; SA'UD MUKHTAR AL-HASHIMI, a faculty member at the King Abdulaziz University, who was sentenced in November 2011 to 30 years in prison; ALI ABDULLAH AL-HAJI, a professor at King Saud University in Riyadh, who was arrested along with 31 others in March 2016 on charges of spying for Iran; and FAHAD AL-QAHTANI, a prominent Saudi economist jailed in 2011, whose health is deteriorating due to conditions in the Al-Ha'ir criminal prison in Riyadh.

Continuing cases: Following six months of protests in Istanbul, Ankara, and Izmir, on June 15, 2021, Melih Bulu was removed from his post as the rector of Bogazici University by a presidential decree. Bulu had been appointed to the position from outside the faculty by a midnight presidential executive order in January. Throughout the first month of protests in support of the Bogazici community's struggle for academic freedom and institutional autonomy, the police used excessive force against peaceful protestors. Trials are still in progress over charges against 108 people, mostly students, who were taken into custody on February 1 and released after giving their statements, as are court hearings in a lawsuit filed on April 19, 2021, against 97 people who joined the protests in Istanbul.

As this issue goes to press, COVID-19-related contingencies have so slowed the daily conduct of bureaucracy that most of the 6,000+ academics who lost their jobs and passports, including those who have been acquitted of terrorism charges, are still waiting for the return of their passports despite the lifting of restrictions on them by the Constitutional Court. TUNA ALTINEL, professor of mathematics at Lyon-1 University in France, who was acquitted of all charges in January 2020, finally received his passport on May 28, 2021, and on June 11 returned to France, where he was welcomed at Lyon-Saint Exupery Airport by his colleagues and the members of academic solidarity networks.

Continuing cases: Emirati professor and economist NASSER BIN GHAITH and two other human rights defenders imprisoned in the United Arab Emirates remain in detention and are reportedly being mistreated in conditions that may amount to torture, according to a United Nations report. Ghaith, who taught at the Abu Dhabi branch of Paris-Sorbonne University, is serving a 10-year sentence handed down in March 2017 for tweets critical of UAE authorities.

RELEASES

Thailand: On May 19, 2021, Endangered Scholars Worldwide learned that two leaders of a Thai student-led prodemocracy movement who were jailed last year have been released after repeated requests for bail, which had been denied. The Criminal Court of Thailand granted bail to PARIT "PENGUIN" CHIWARAK, 22, and CHAIAMORN "AMMY" KAEWWIBOON-PAN, 32, both charged under Thai lese majeste laws. The pair spent months in pretrial detention. According to the statement published by the court, both have agreed to remain in Thailand, attend future court hearings, and refrain from engaging in activities intended to undermine the monarchy and activities that would lead to civil unrest. While in prison, Parit was hospitalized due to the deterioration of his health as a result of a 46-day hunger strike to demand the right to be granted bail. Parit, who was detained on February 9, 2021, had been charged for his participation in a Bangkok protest last year. He began a hunger strike on March 15, 2021. Chaiamorn was detained for burning a portrait of Thailand's king in Bangkok's Central Prison. The Thai lese majeste laws, which forbid insulting the monarchy, carry a penalty of up to 15 years in prison for each offense.

Turkey: On June 15, 2021, CIHAN ERDAL, sociology PhD candidate at Carleton University and a former HDP executive committee member, was released under judicial supervision. On June 21, 2021, EMINE BEYZA USTUN, civil engineer and former HDP deputy at the Turkish Grand National Assembly was released on June 21, 2021, under judicial supervision. Both trials will resume on September 20, 2021.
